Once a player signs a WPD application form she is agreeing to the following declarations:

- (a) The applicant acknowledges the sole authority of WGAI to establish Rules and Conditions as published in the annual handbook of members Rules & Regulations, and agree to abide by these and any amendments that may, from time to time, be made by WGAI.
- (b) The applicant accepts that any tournament in which she participates, she will abide by the decisions of the TC. In case of any escalations, the decision of WGAI's designated committees shall be final and binding.
- (c) The applicant undertakes to conduct herself in accordance with code of ethics of the WGAI.

- (d) The applicant agrees to submit to drug testing, which will be conducted by or on behalf of WGAI in accordance with National/International Golf Event Policy in effect. Applicant agrees that all and any disciplinary proceedings and/or disputes that may arise as a result of any such drugs shall be resolved in accordance with the terms of the policy.

PLAYER MEMBERSHIP FEE : INR 7,500/- for the season HWPGT- 2018

- All cheques/drafts are to be made in the name of "Women's Golf Association of India" payable at New Delhi, may be sent or physically deposited at D-1033, New Friends Colony, New-Delhi-110 065
- Penalty of Rs. 500 will be levied on return/non clearance of cheque/drafts.
- Only those outstation cheques which are PAYABLE AT PAR WILL BE ACCEPTED.

Foreign Passport holders

PLAYER MEMBERSHIP FEE : INR 7,500/- for the season HWPGT 2018.

**ADVISORY FOR PROFESSIONAL PLAYERS:**

- Foreign passport holders will require a PAN CARD in order to get certificate of withholding Tax.
- Players will be able to procure a business visa if they have a PAN CARD number
- If players do not have a PAN CARD, they will be able to apply for a Tourist Visa. The player will be restricted in the duration of stay in India for a period of 2 months. Restriction for re entry to India is 2 months from the date of departure after the player has stayed in India for 2 months.
